# Accreditation

Phase one of the QMentum (Accreditation) process is now complete. 715 staff completed the Self-Assessment questionnaire and a total of 865 staff completed the Corporate Patient Safety Culture Survey. A big thank you to all those staff who helped make this phase a success!

### What's Next?

Based on these submitted questionnaires/surveys, each client and support service team has received a "Quality Performance Roadmap" from Accreditation Canada (formerly CCHSA). These roadmaps indicate areas of excellence and opportunities for improvement. Those areas that are flagged as priorities for improvement will include required organizational practices (ROP's). A Required Organizational Practice is an essential practice that organizations must have in place to enhance patient/client safety and minimize risk, e.g. medication reconciliation upon admission, falls prevention, and communication of safety to patients and families.

#### Our Focus on Quality and Safety

The Accreditation Process complements our priority work that has been already identified in our 2008 Strategic Directions, most notably, "embedding patient quality and safety into our culture". Accreditation Canada provides guidelines to our organization through its eight dimensions of quality: population focus, accessibility, safety, worklife, client-centered services, continuity of services efficiency and effectiveness.

### **Medication Reconciliation**

Medication Reconciliation is one of seven Safer Healthcare Now Patient Safety Interventions in which WRH is participating, as well as one of the Canadian Counsel on Health Care Services Accreditation's (CCHSA) 21 required Organizational Practices (ROP's) relating to patient safety. In collaboration with Pharmacy the inpatient Oncology Unit (4WT) as well as the Palliative Care Unit (CC8) at Windsor Regional Hospital will be the first units to initiate Medication Reconciliation, beginning the first week of May, 2008. This patient safety initiative will then roll out sequentially across the corporation, beginning in July for Medicine 1, 2, 3, and Paediatrics; in August for Surgery 1, 2, and Family Birthing; and in November for the Emergency Department. Education for medication reconciliation will be conducted in patient care areas by Clinical Practice Leaders in collaboration with Pharmacy, and in addition an elearning course is available and will be assigned by Learning Resources.
